

**ORDINANCE NO. O2-1-20**

**AN ORDINANCE AMENDING THE OFFICIAL FLOODPLAIN ZONING MAP OF THE VILLAGE OF ASHWAUBENON, BROWN COUNTY, WISCONSIN FOR PARCELS VA-L197, VA-L202, VA-L197-2, VA-L197-4, VA-L197-5, VA-L197-7, VA-L197-3**

**WHEREAS**, the Village of Ashwaubenon has heretofore adopted a Floodplain Zoning Map under the authority of §61.35, §62.23, and §87.30 Wis. Stats.; and

**WHEREAS**, the Village of Ashwaubenon has adopted Chapter 14 Floodplain and Shoreland in accordance with requirements of participation in the National Flood Insurance Program; and

**WHEREAS**, Chapter 14 Floodplain and Shoreland Article 8 of the Ashwaubenon Municipal Code contains a process to amend the floodplain zoning district boundaries; and

**WHEREAS**, the Village of Ashwaubenon received a requested floodplain zoning map amendment from David Chrouser, Agent for property owner Julia Gay – Marcella Ambrosius Revocable Trust; and

**WHEREAS**, the Village Clerk-Treasurer has published a Class II notice of public hearing regarding such proposed floodplain zoning change, and a public hearing had been held at the Village Hall on February 25, 2020 at 6:30 p.m. whereupon the Village Board has heard all interested persons, and/or their agents and attorneys;

**NOW THEREFORE BE IT RESOLVED**, after considering the recommendations of the Plan Commission, and testimony received at Public Hearing on February 25, 2020, the Village Board hereby amends the Village of Ashwaubenon Floodplain Zoning Map.

**SECTION 2.** All ordinances or parts of ordinances, in conflict herewith are hereby repealed.

**SECTION 3.** This ordinance shall take effect upon its adoption and publication.


