

VILLAGE OF ASHWAUBENON
APPLICATION FOR TEMPORARY EXPANSION OF LICENSED
PREMISES

Ashwaubenon Municipal Code Sections 3-2-92 and 9-1-6 authorizes the Clerk-Treasurer to issue alcohol beverage licenses which shall temporarily expand the premises description for establishments currently holding a liquor license. This application must be submitted to the Office of the Clerk-Treasurer along with the additional information requested below. The area to be included in the temporary expansion is subject to the requirements of Wis. Stat. Chapter 125 and all relevant village ordinances. Any expansion of the premises as approved by the Clerk-Treasurer will be removed from the liquor license no later than November 1, 2020, 11:59 p.m. at which time the licensed premises will return to the premise description as listed on the original liquor license application.

REGULATIONS FOR TEMPORARY EXPANSION OF LICENSED PREMISES

1. Alcohol beverages shall only be served to patrons of the establishment by a server in the temporarily expanded area. No carryout or carry-in of alcohol beverages by a patron to and from the area shall be permitted.
2. Each establishment shall be responsible for monitoring the area to ensure that customers are of legal drinking age and that alcohol beverages are not removed from the premises.
3. The establishment is responsible to ensure that the temporarily expanded area is kept clean at all times.
4. The sale of alcohol beverages in the temporarily expanded area shall be limited to the hours of 11:00 a.m. to 11:00 p.m. All alcohol shall be removed from the area no later than 11:30 p.m.
5. If the temporary expanded area is on a village sidewalk, pedestrian access of at least 4 feet must be maintained.
6. Violations of these requirements, Wis. Stats. Ch. 125 or municipal ordinances adopted under the authority of Ch. 125 may result in the temporarily expanded area being removed from the liquor license.
